What does Cognate and Non-Cognate mean?

There are two common pathways to joining the Next Generation programme as a graduate. You can join our programme as a 'cognate' degree holder. This means that you hold an Undergraduate or Masters degree that is a related field of study to the graduate scheme. You can also join our programme as a 'non-cognate' degree holder. This means that you hold a degree that isn't in real estate or related to the graduate scheme pathway, but we will sponsor and support you through a qualification to align you with the cognate students.

For example, for the Commercial Real Estate pathway a cognate student would need a degree accredited by the Royal Institution of Chartered Surveyors (RICS). Non cognate students will take a Masters that is accredited by the RICS – enabling you to sit your exams to become a Chartered Surveyor.

The Application Process

You will initially complete an application form along with your CV. If this meets our requirements, then you will be asked to complete a job-focussed test. From there we will invite successful candidates to an assessment centre that will consist of a group activity and individual interview.

Placements and Internships

Nearly all of our business streams take on internships or placement students, for either a short period of 4 weeks for an internship or up to 12 months for an industrial placement. These are a great opportunity to you to get to know our business and get some relevant work experience, and it is also a great opportunity for us to get to know potential new graduates.
